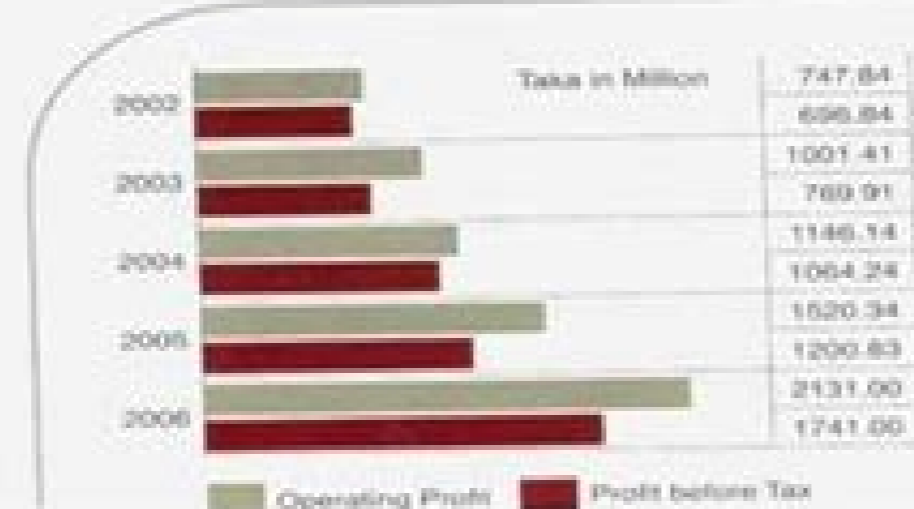
**CAPITAL ADEQUACY RATIO**



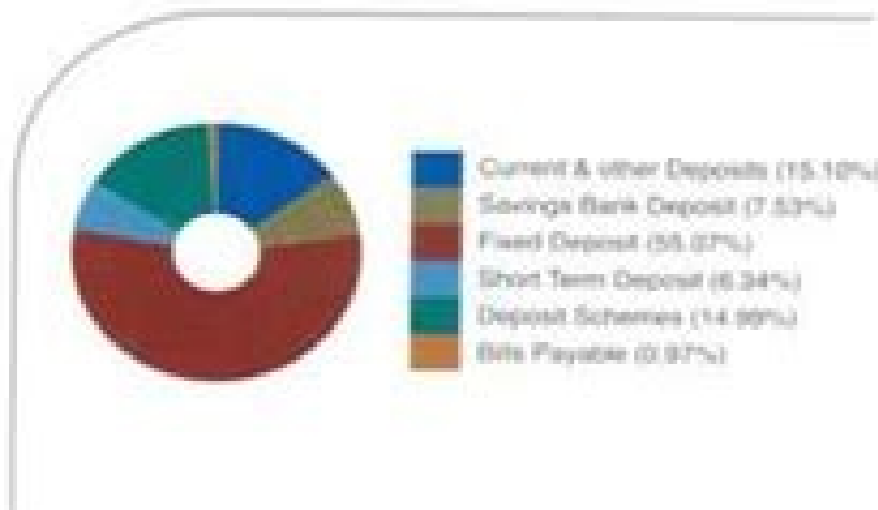
**COUNTRY WISE INFLOW OF FOREIGN REMITTANCE**



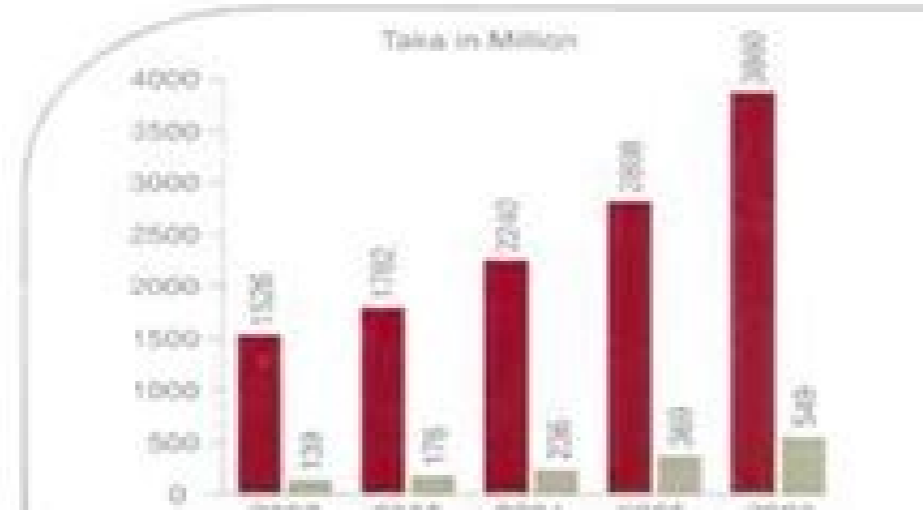
